**Don't Break the Law!
Don't Apply Pesticides without a License!**

Certification Requirements for Commercial Landscape Maintenance Operators When Applying Pesticides

Florida Law requires that anyone performing pest control services (applying insecticides, herbicides, and fungicides – including ‘weed-n-feed’ products) must have a pest control business license from the Department of Agriculture & Consumer Services. If you are a landscape maintenance operator, you cannot apply any pesticides (herbicides, insecticides, or fungicides) as part of your services without first obtaining the proper certification.

Penalties for breaking the law can be as high as \$5,000 per violation!

The Limited Certification for Commercial Landscape Maintenance certificate is available to commercial landscape maintenance operators for pesticide application. This certificate allows you to make pesticide applications to plant beds and ornamental plants only. It does not allow you to make applications to lawns or turfgrass, nor to operate a pest control business.

How to Apply for Limited Certification in Commercial Landscape Maintenance

STEP 1: Contact the Bureau of Entomology & Pest Control and obtain an application package which includes the following:

- DACS Form 13604: Limited Certification for Commercial Landscape Maintenance Personnel
- DACS Form 13654: Certificate of Insurance
- Instructions for Limited Certification for Commercial Landscape Maintenance Personnel

STEP 2: Call the University of Florida, IFAS Publications Office at 1-800-226-1764 to order the following study manuals:

- Applying Pesticides Correctly (Item SM-1)
 - Ornamental & Turf Manual (Item SM-7)
- (These are the books you will need to study for the examination.)

STEP 3: Find 6 hours of CEU's by calling your local chapter of the LMA, the Landscape Maintenance Association state office, or your local County Extension Office.

STEP 4: Fill out and send in the application form. You will need to include your 6 CEU's, a photo, and a check in the amount of \$150, made payable to DACS for the examination fee.

STEP 5: Call your local County Extension Office to find the dates and times the Limited Commercial Landscape Maintenance Examination will be given.

STEP 6: Your exam results will be mailed to you. If you pass, you will need to submit proof of insurance before your certificate will be issued. If you fail, you must resubmit another application and fee.

STEP 7: Renew your certificate annually with 4 CEU's (ex. 2hrs Core, 2hrs Lawn).

What You Can Do After You Have Limited Certification in Commercial Landscape Maintenance

You are allowed to apply herbicides to control weeds in plant beds and to perform integrated pest management on ornamental plants using insecticides and fungicides having the signal word CAUTION on the label. However, the application equipment that may be used by a person certified pursuant to this section is limited to portable, hand-held 3 gallon compressed air sprayers, or back pack sprayers having no more than a 5 gallon capacity, not including power equipment.

What You Can't Do

- Apply any pesticide (insecticide, herbicide, or fungicide) to the lawn or turf. This includes fertilizer/herbicide mixtures.
- Operate a pest control business.
- Use power sprayers or any equipment with a capacity of more than 5 gallons.
