BCS Cry1Ab COTTON INSECT RESISTANT COTTON SEED, (*Bacillus thuringiensis*), (Bayer CropScience LP, EUP Reg. No. 264-EUP-140) for control of lepidopteran cotton pests on cotton. Written comments were received from FDACS Scientific Evaluation Section, Pesticide Laboratory Section, Bureau of Chemical Residue Laboratory, Bureau of Compliance Monitoring, and FFWCC. The Committee recommended approval of this EUP. **(WH)**

BCS Cry1Ab x Cry2Ae COTTON (TwinLink cotton) INSECT RESISTANT COTTON SEED, (*Bacillus thuringiensis*) (Bayer CropScience LP, EUP Reg. No. 264-EUP-143), for control of lepidopteran cotton pests on cotton. Written comments were received from FDACS Scientific Evaluation Section, Pesticide Laboratory Section, Bureau of Chemical Residue Laboratory, Bureau of Compliance Monitoring, and FFWCC. Written comments were received from FDACS Scientific Evaluation Section, Pesticide Laboratory Section, Bureau of Chemical Residue Laboratory, Bureau of Compliance Monitoring, FDEP and FFWCC. The Committee recommended conditional approval of this SLN subject to revision of the label after consultation with EPA, receipt of requested methodology and standards, and a favorable review of the efficacy data. **(GT)**

DELEGATE® WG, (spinetoram), (Dow AgroSciences LLC, EPA Reg. No. 62719-541) for low volume ground application in citrus for control of Asian citrus psyllid. Written comments were received from FDACS Scientific Evaluation Section, Pesticide Laboratory Section, Bureau of Chemical Residue Laboratory, Bureau of Compliance Monitoring, FDEP and FFWCC. The Committee recommended conditional approval of this SLN subject to revision of the label after consultation with EPA, receipt of requested analytical standards and a favorable review of the efficacy data. **(GT)**
