NAI REGISTRATIONS

CELSIUS WG HERBICIDE (iodosulfuron and thien carbazone-methyl), (Bayer Environmental Science, EPA Reg. No. 432-1507) for control of annual and perennial broadleaf weeds and grasses in warm-season turf types in commercial and residential sites. (AS)

SLN/SNU REGISTRATION

MUSTANG® INSECTICIDE (zeta-cypermethrin), (FMC Corporation, EPA Reg. No. 279-3126) for low volume aerial application to Florida citrus for control of Asian citrus psyllids. (GT)

SNU REGISTRATIONS

PORTAL® MITICIDE/INSECTICIDE (fenpyroximate), (Nichino America, Inc., EPA Reg. No. 71711-19) for aerial application on citrus and ground application on fruiting vegetables, melons and 'low-growing' berries. (GT)

ROZOL® VOLE BAIT, (chlorophacinone), (Liphatech, Inc., EPA Reg. No. 7173-242) for control of voles in orchards, non-crop areas, nurseries, and tree and forestry plantations. The Committee will consider the revised label submitted by the registrant. (GT)

NAI REGISTRATIONS

AFLA-GUARD (*Aspergillus flavus* NRRL 21882), (Circle One Global, Inc., EPA Reg. No. 75624-2) to displace aflatoxin-producing fungi in peanuts and corn. Additional information regarding the tolerance exemption for corn and certain label language was received and approved by the Bureau of Chemical Residue Laboratories and the Bureau of Compliance Monitoring. This brand was registered effective **January 20, 2010**. (RM)

DR. T'S SLUG & SNAIL KILLER, (sodium ferric EDTA), (NAI) (Safer Inc. [a wholly owned subsidiary of Woodstream Corporation], EPA Reg. No. 42697-61) for control of slugs and snails on lawns, home perimeters, around ornamental plants (flowers, shrubs, and trees) and in home gardens. Registrant provided the requested supporting toxicological and residue information. This brand was registered effective **January 21, 2010**. (WH)

SLN REGISTRATIONS

INTREPID 2F (methoxyfenozide), (SLN) (Dow AgroSciences LLC, EPA Reg. No. 62719-442) for control of lepidoptera larvae infesting citrus fruits (crop group 10). **EPA SLN NO. FL-100001** was issued effective **January 19, 2010** after receipt of favorable IFAS review. (WH)

PENDING BUSINESS

ALTO 100 SL FUNGICIDE, (cyproconazole), **(NAI)** (Syngenta Crop Protection, Inc., EPA Reg. No. 100-1226) to control diseases in soybeans. Awaiting additional information requested by the Committee. **(RM)**

CADET HERBICIDE (fluthiacet-methyl), **(NAI)** (FMC Agricultural Products, EPA Reg. No. 279-3338) for control of velvetleaf and other broadleaf weeds in soybeans, field corn, sweet corn for processing only, and popcorn. Awaiting a response from the registrant for the information requested by the Committee. **(AS)**

CAPRENO HERBICIDE, (thiencarbazone-methyl), **(NAI)** (Bayer CropScience, EPA Reg. No. 264-1063) for control of annual broadleaf and grass weeds in corn. Awaiting a response from the registrant for the information requested by the Committee. **(AS)**

FLAZASULFURON 25WG HERBICIDE (flazasulfuron), **(NAI)** (ISK Biosciences Corporation, EPA Reg. No. 71512-12) for control of overseeded cool-season grasses as well as control of annual and perennial grasses, sedges, and broadleaf weeds in Bermudagrass, Zoysiagrass and certain other warm-season turfgrasses. Awaiting the information requested by the Committee. **(AS)**

FOLICUR 3.6 FOLIAR FUNGICIDE, (tebuconazole), **(SNU)** (Bayer CropScience, EPA Reg. No. 264-752) for use on food crops such as beans, corn, cucurbits, and leafy brassica greens. Awaiting information regarding effects on bees. **(RM)**

IODOSULFURON TURF HERBICIDE, (iodosulfuron methyl sodium), **(NAI)** (Bayer Environmental Science, EPA Reg. No. 432-1404) for control of weeds on turf. Awaiting the information requested by the Committee. **(AS)**

IMPACT HERBICIDE, (topramezone), **(NAI)** (AMVAC Chemical Corporation, EPA Reg. No. 5481-524) for postemergence weed control in field corn (grown for grain, silage or seed) popcorn and sweet corn. Awaiting a response from the registrant on label discrepancies. **(CC)**

PENDING BUSINESS (CONT'D)

MERIT 2F INSECTICIDE, (imidacloprid), **(SLN)** (Bayer CropScience LP, EPA Reg. No. 432-1312) to control Asian Citrus Psyllid in citrus. DACS received the December 1, 2008 IFAS review, which noted the lack of site specific Florida efficacy data for the product by reviewers. The review was provided to the registrant, and they are in the process of compiling the lacking efficacy data for re-submission to IFAS. The label clarification was resolved at an interim meeting with FFWCC. **(WH)**

OF COURSE, (rhamnolipid biosurfactant), **(NAI)** (Jeneil Biosurfactant Co., EPA Reg. No. 72431-1) to control fungi on turf grass. Awaiting a response from the registrant to the Committee members' labeling questions. **(RM)**

REFLEX HERBICIDE (fomesafen), **(NAI)** (Syngenta Crop Protection, Inc., EPA Reg. No. 100-993) for control of broadleaf weed grasses and sedges in cotton, dry beans, snap beans and soybeans. Awaiting a response from the registrant to address the review comments of the Committee. **(AS)**

WG63 TURF AND ORNAMENTAL (thiencarbazone-methyl), **(NAI)** (Bayer Environmental Science, EPA Reg. No. 432-1475) for control of broadleaf weeds in warm-season turf. Awaiting the information requested by the Committee. **(AS)**
